In accordance with Borough Ordinance #768-15 the licensing of commercial landscapers doing business in the Borough of Little Silver is required; a copy is attached for your review. **Please note Item 1, Section C of the ordinance as there has been a change to the permissible hours of operation for landscapers operating in the Borough.**

Enclosed is the 2020 application, the fee is \$50.00 annually and the issued permit will be good thru February 1, 2021. The completed application must be returned to the Borough Clerk's office, along with the \$50.00 fee, prior to **January 31, 2020**, at which time a sticker permit will be issued. **STICKERS MUST BE DISPLAYED ON LEFT REAR BUMPER**, and can be positioned over the prior year sticker.

**Please note that beginning January 1, 2020 there are no longer zones for brush placement or pick-up. Brush only can be put to the curb at any time from January thru October. Leaves only can be put to the curb from November 2<sup>nd</sup> thru December 29<sup>th</sup>.**




ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER V "POLICE REGULATIONS" SECTION 5.3, "NOISE", OF THE CODE OF THE BOROUGH OF LITTLE SILVER, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Little Silver, County of Monmouth, and State of New Jersey, as follows:

1. That Chapter 5, Section 5.3 entitled "Noise" shall be replaced in its entirety as follows:
  - a. No person shall make, aid, countenance or assist in making any improper noise, riot, disturbance or breach of the peace in or upon any street, highway, thoroughfare, sidewalk, building or other public or quasi-public place, or upon private property which is not his own, or disquiet or disturb any congregation or assembly of any kind whatsoever in any church or other building by any rude, disorderly or indecent behavior of any kind
  - b. No person shall make or permit the making of any disturbing noise by the use of a phonograph, radio, television, musical instrument, or devices, producing or reproducing of sound in such manner as to disturb the peace, quiet and comfort of their neighbors. The operation of any such sets, instruments, or devices between the hours of 10:00 p.m. and 7:00 a.m., Monday through Saturday and 10:00 p.m. and 9:00 a.m., Sunday, in such a manner as to be plainly audible at a distance of 50 feet from the building or vehicle in which it is located, shall be prima facie evidence of a violation of this section.
  - c. No audible noise by landscape, erection, excavation, demolition, alteration or repair of any building other than between the hours of 7:30 a.m. and 7:00 p.m. Monday through Friday and 9:00 a.m. and 6:00 p.m. on Saturday and Sunday by a landscaper or contractor for hire, except in the case of urgent matters and the interest of public health and safety. Any of the aforementioned performed by a property owner or tenant thereof between the hours of 7:30 a.m. and 8:00 p.m. Monday thru Friday, and 9:00 a.m. and 8:00 p.m. Saturday and Sunday.
2. That, in the event that any portion of this Ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the Ordinance actually adjudged to be invalid, and the remaining portions of this Ordinance shall be deemed severable therefrom and shall not be affected.
3. That this Ordinance shall take effect upon final passage and publication in accordance with the law.

ORDINANCE NO. 768-15  
AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF LITTLE SILVER IN THE  
COUNTY OF MONMOUTH AMENDING AND SUPPLEMENTING CHAPTER VI  
"LICENSING-GENERAL"

BE IT ORDAINED by the Council of the Borough of Little Silver, in the County of Monmouth, in the State of New Jersey, as follows:

**6-6.1 Purpose.**

- a. The purpose of this Ordinance is to amend Chapter VI, adding and creating Section 7 "Landscape Registration" to ensure that persons defined in subsection 6-7.2 are cognizant of the Borough's regulations regarding branch, brush and leaf collection.
- b. No person shall landscape on or engage in any landscaping on any public or private property within the Borough for hire without first registering with the Municipal Clerk on forms to be supplied by the Borough.

**6.6-2 Definitions**

For the purpose of this section, the following terms, phrases, words and their derivation shall have the meaning given herein. When not inconsistent with the context, words used in the present text include the future, words in the plural number include the singular and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

**FOR HIRE** - Shall mean to demand and/or accept payment or compensation for completion of services.

**LANDSCAPE AND LANDSCAPING** - shall mean to be in the business, occupation or trade of adorning or improving property or portion of property by trimming or cutting grass and/or shrubs; by planting, installing or removing leaves, branches, grass, flowers, mulch, hedges or shrubs; or by planting, removing or installing trees. As used in this section, landscape and landscaping shall also refer to solicitation of the above referenced services.

**PERSON** – shall mean any individual or entity whose existence is recognized by law, including, but not limited to, any partnership, corporation (for-profit, nonprofit or municipal or its agencies), firm, association or any combination of the foregoing.

**6.6-3 Application for registration, fees.**

- a. At the time of registration, applicants shall provide proof that they have received a copy of and will comply with the provisions of the Borough's ordinance, policies and schedules regulating its leaf, brush and branch collection program.
- b. Every registration shall be issued and renewed on an annual basis, effective February of each year, upon payment of an annual fee to the Borough in the amount of fifty (\$50.00) dollars. The first year, 2015 registrations shall be effective July at a cost of twenty (\$25.00) dollars and will run until February 2016.


- c. No registration shall be required for any owner, lessee or tenant of real property who shall personally perform activities otherwise requiring a registration; except that all such work must otherwise comply with the Borough's ordinances, policies and schedules.
- d. The Borough makes no guarantee or representation regarding the fitness, knowledge or qualification of any person that is registered by the Borough to engage in landscaping for hire.


#### 6.6-4 Violations and Penalties

- a. Any person(s), firm(s) or corporation(s) who violate any provision of this section shall, upon conviction thereof in Municipal Court, pay a fine not exceeding two hundred (\$200.00) dollars. Each day that such violation shall continue shall be considered a separate violation.

BEGINNING JANUARY 1, 2020 BRUSH ONLY CAN BE PUT TO THE CURB AT ANY TIME FROM JANUARY THRU OCTOBER

**THERE ARE NO LONGER  
ZONES FOR BRUSH PLACEMENT OR PICK-UP**

THE DEPARTMENT OF PUBLIC WORKS WILL BE PICKING UP BRUSH CONTINUALLY DURING THIS TIME

BRANCHES MUST BE NO MORE THAN  
4' IN LENGTH AND 12" IN DIAMETER

CHRISTMAS TREES CAN BE PLACED TO CURB AT ANY TIME  
DURING THE BRUSH COLLECTION PERIOD

LEAVES ONLY CAN BE PUT TO THE CURB FROM  
NOVEMBER 2<sup>ND</sup> THRU DECEMBER 29<sup>TH</sup>

THE DEPARTMENT OF PUBLIC WORKS WILL BE PICKING UP LEAVES CONTINUALLY DURING THIS TIME

PLEASE DO NOT MIX BRUSH AND LEAVES,  
AS PER STATE LAW THEY MUST BE RECYCLED SEPARATELY

PLEASE HELP US WITH DRAINAGE AND DO NOT PLACE BRUSH OR  
LEAVES WITHIN 10 FEET OF A STORM DRAIN
